Re: Investigation of Environmental Protection Commission's Board of Directors
Hillsborough County, Florida – Additional Names and Information

Dear Mr. Hauck:

On July 29, 2007, We the people of Hillsborough County, including all jurisdictions therein, sent a letter to Governor Crist respectfully requesting that he investigate the actions and the composition of the board of directors of the Hillsborough County Environmental Protection Commission (EPC) for reasons outlined. It is my understanding that this letter has been forwarded to your office for review.

Please find attached additional names that have been added onto this letter of request. This list represents dozens of organizations and individuals now totaling over **10,000** people making this request. And, the names continue to come in.

Since our original letter, another EPC meeting has taken place July 26, 2007. Attached is the closed captioning for this meeting. Please note, **OVERWHELMINGLY** are the voices of the citizenry to not only keep our wetlands division, but to have stricter standards in place for our natural resources - wetlands/mangroves/water.

We believe the past actions of this board are unlawful for numerous reasons and we believe the state has the power to intervene. State law provides for safeguards to protect the environment against contrary decisions by agencies **charged to protect the** environment. There has been no duplication by EPC with the state or federal reviewing agencies cited or proven on the record by anyone, including the commission. As a matter of fact, the record shows just the opposite. Why would a commissioner *after setting the hearings* start asking for proof of duplication if this were no so???? (See attached) This is purely a politically motivated move by the commission, not one based on fact or logic.

What about the four (4) comprehensive plans in the jurisdictions within Hillsborough County? Land Development Codes? Their ordinances? Our EPC wetland rules are interwoven throughout rules, laws and policies in all four jurisdictions. This is not an arbitrary issue.

Have they consulted Tampa, Temple Terrace or Plant City who share this wetland/mangrove protection yet? No. As a matter of fact, the cities of Tampa and Temple Terrace have also noted the inequity and asked the Governor for seats on the board of the EPC.

On August 16, 2007, two public hearings will take place where the EPC Board will be deciding whether to adopt amendments to our wetlands rule, Rule 1-11, incorporating part of a hybrid proposal for streamlining the process by Dr. Garrity of the EPC or eliminate the wetlands division entirely along with our mangrove protections, Rule 1-14. Even the Department of Environmental Protection has been quoted in articles that our EPC has done a good job with this protection, and actually wants our EPC to take over MORE review and regulatory power of wetlands and mangroves from them.

With the State of Florida having to cut \$1.5 BILLION out of its budget, who will take over the wetlands review? The state cannot handle the workload now with a strained staff covering 16 counties in our water management district. How are they going to be able to provide oversight? Our EPC response time is within HOURS of a complaint...the state agencies respond within DAYS. A perfect example is Cypress Creek Town Center where a complaint was filed on a Thursday with Army Corp, Southwest Florida Water Management District and our EPC (because Cypress Creek is the headwaters of Hillsborough County's Hillsborough River.) EPC was out within 2 hours; SWFWMD and ACOE did not respond until the following week - Monday and Tuesday.

Finally, Monroe County has just eliminated its Environmental Marine Department (the Florida Keys!!!) based on "budget" reasons. Coincidence? (See prior letter)

This nonsensical argument by our commission has been tried at the state level during legislative session for years, and our state legislators have seen through the charade. If our commission is allowed to dismantle our precious wetlands protection in Hillsborough County when we have a state law mandating and creating our Environmental Protection Commission due to the one-of-its-kind eco-system in the state, then the future for the whole state looks grim for protecting our water and natural resources.
